<p><b>Authorizing Casino Gaming</b> The proposed amendment to section 9 of article 1 of the Constitution would allow the Legislature to authorize up to seven casinos in New York State for the legislated purposes of promoting job growth, increasing aid to schools, and permitting local governments to lower property taxes through revenues generated. In exchange for giving up its claim to disputed parcels, the State would get land to be incorporated into the forest preserve that would benefit the forest preserve more than the disputed parcels currently do. <p><b>In Relation to a Land Exchange in the State Forest Preserve with NYCO Minerals, Inc.</b> The proposed amendment to section 1 of article 14 of the Constitution would authorize the Legislature to convey forest preserve land located in the town of Lewis, Essex County, to NYCO Minerals, a private company that plans on expanding an existing mine that adjoins the forest preserve land. In exchange, NYCO Minerals would give the State at least the same amount of land of at least the same value, with a minimum assessed value of \$1 million, to be added to the forest preserve. When NYCO Minerals finishes mining, it would restore the condition of the land and return it to the forest preserve. Shall the proposed amendment be approved?</p> <p style="text-align: center;">YES      NO <input type="radio"/>      <input type="radio"/></p>	<p><b>Increasing Age until which Certain State Judges Can Serve</b> The proposed amendment to the Constitution, amending sections 2 and 25 of article 6, would increase the maximum age until which certain state judges may serve as follows: (a) a Justice of the Supreme Court would be eligible for five additional two-year terms after the present retirement age of 70, instead of the three such terms currently authorized; and (b) a Judge of the Court of Appeals who reaches the age of 70 while in office would be permitted to remain in service on the Court for up to 10 years beyond the present retirement age of 70 in order to complete the term to which that Judge was appointed. Shall the proposed amendment be approved?</p> <p style="text-align: center;">YES      NO <input type="radio"/>      <input type="radio"/></p>	<p><b>Submitting Resolution of Corinth Town Board Establishing Volunteer Ambulance Workers Service Award Program to the Electors of the Town of Corinth at the Biennial Election to be held on November 5, 2013.</b> Shall the defined contribution Service Award Program for members of the Town of Corinth Emergency Squad approved by Resolution of the Corinth Town Board on September 5, 2013, which Program provides, among other things, that (a) the Town of Corinth shall contribute \$700 to the Program annually on behalf of each participant credited with a year of ambulance service for calendar years after 2013 under the Town of Corinth Emergency Squad Service Award Program Point System; (b) the estimated annual cost of the Program for 2014, payable in 2015, may be as much as \$12,000, including the cost of administration, but is expected to decrease to about \$7,000 after five (5) years when the Prior Service Cost (the cost of service awards earned for active volunteer ambulance service before 2014) will be fully paid; (c) no portion of the estimated annual cost of the Program will be paid by any other political subdivision; (d) the estimated annual cost of the Program per participant for 2014, payable in 2015, may be as much as \$1,200, including the cost of administration, but is expected to decrease to about \$700 after five (5) years when the Prior Service Cost will be fully paid; (e) the estimated annual administration fee for 2014 is \$500; (f) a \$700 prior service contribution shall be credited to the Program account of a participant for each calendar year 2012 and 2013, and for the period February 24, 2011 to December 31, 2011, during which the participant was at least 18 years old and would have earned a year of service credit under the Point System, at a total estimated cost of \$5,000 per year for five (5) years; (g) persons who continue to volunteer after attaining the Entitlement Age and having been paid a Service Award shall continue to have the opportunity to earn program credit and to be paid additional service awards; and (h) the Program shall take effect on January 1, 2014, be approved?</p> <p style="text-align: center;">YES      NO <input type="radio"/>      <input type="radio"/></p>
