Meeting Minutes

On a motion by Mr. Wood, seconded by Mr. Lucia the minutes of the February 10, 2016 meeting were unanimously approved.

Mr. Hellwig presented the following:

SOCIAL PROGRAMS

Acceptance of a grant from the NYS Office of Temporary and Disability Assistance in the amount of \$36,554 for the purpose of extending shelter hours for the homeless.

Agreement with the Town of Corinth to provide \$20,000 in funding for the purchase of a senior transportation vehicle.

Authorization for renewal agreement with the Senior Citizens Center of Saratoga Springs to provide \$20,000 in funding for the center's community connections program.

Authorization for renewal agreements with nine (9) home care agencies to provided expanded in-home services for the elderly.

Authorization for renewal contract with Home Helpers & Direct Link to provide additional caregiver support i.e. respite services under the Balancing Incentive Program Caregiver Support Program Grant.

Authorization for a contract with Mechanicville Area Community Services Center for the Elder Care Services Program in the amount of \$20,000.

TECHNOLOGY

Authorizing amendments to the Policies & Procedures Manual relative to email provider being named in a generic sense.

PERSONNEL & INSURANCE

Amending the Policies & Procedures manual relative to the Health Insurance Policy for employees.

ECONOMIC DEVELOPMENT

Request for Home Rule Legislation authorizing the County to transfer ownership of Kinns Road Park to the Town of Clifton Park which is currently reforested land.

EQUALIZATION & ASSESSMENT

Accepting tender offers for seven pre-auction parcels towns of Clifton Park, Edinburg, Galway, Greenfield, Malta, and Saratoga. These parcels will be removed from the auction list as a result of these payments and deeded back to the original owners.

Authorizing the conveyance of 2 parcels located in the Town of Halfmoon to the Town who will be purchasing these parcels pre-auction.

PUBLIC HEALTH

Proclaiming April as Organ Donation Awareness Month.

Authorize an amendment to the contract with Transitional Services Association in the amount of \$9,530 for an additional housing bed.

Authorize the acceptance of a grant from the State Office of Alcohol and Substance Abuse Services; enter into a contract with the Albany Diocesan School Board to provide prevention education programs in schools in the County of Saratoga, and amending the budget in relation thereto.

Authorizing the acceptance of a one-time start-up grant from the Office of Mental Health and the Office of Alcohol and Substance Abuse Services in the amount of \$25,000 for home and community based services and amending the budget in relation thereto.

Authorize a name change from Saratoga County Public Health Nursing Service to Saratoga County Public Health Services as a result of the closure of the County's Certified Home Health Agency.

Accepting a five year grant from the NYS Department of Health in the amount of \$188,305 associated with the Lead Poisoning Prevention Program and amending the budget in relation thereto.

PUBLIC SAFETY

Authorization to re-appropriate \$80,565.01 which is unspent funds from a 2014 Interoperability Grant that was accepted and placed in the Emergency Services Budget.

Authorize a contract with Brian Quinn, Esq., to provide Appellate attorney services for Criminal and Family Court cases handled through the Conflict Defender's office at Salary Grade 18.

Authorizing a contract with Jody O'Neill to provide social work and case management for Criminal and Family Court cases through the Public Defender's office for an amount not to exceed \$25,000.

Authorizing acceptance of a Domestic Violence Prosecution Grant from the New York State Division of Criminal Justice Services in the amount of \$35,600. The County has been receiving this grant for ten (10) years and off sets the cost associated with prosecuting those cases. It is the same amount of funding received last year and in prior years.

Proclaiming April 10-16, 2016 as National Crime Victims' Rights Week in Saratoga County.

Proclaiming the second full week in April, April 11-17, 2016, as National Public Safety Telecommunicator's Week.

Accepting a Public Safety Answering Points Grant in the amount of \$148,969 from the NYS Division of Homeland Security and Emergency Services for personnel costs.

Authorizing participation in the 2016 State STOP-DWI Program and contracts with local agency participants.

CHAIRMAN'S ITEM

Appointing members to the Tourism Advisory Committee which is a nine member Board and was approved in the local law adopted last month.

LAW AND FINANCE

Authorize a contract with Gottado Contracting LLC for long term sewer sludge hauling from the Sewer District's treatment plant until which time that the Sewer District designs, constructs or finds an alternative to hauling the sludge to a landfill in the western part of the State.

RESOLUTION 67 - 2016

Introduced by Supervisors Lucia, Allen, Congdon, DeLucia, Martin, Szczepaniak, and Tollisen

AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE NEW YORK STATE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE FOR THE PROVISION OF SHELTER TO THE HOMELESS IN COLD WEATHER CONDITIONS, AUTHORIZING AN AGREEMENT WITH SHELTERS

OF SARATOGA, INC. FOR SHELTER SERVICES, AND AMENDING THE BUDGET IN RELATION THERETO

WHEREAS, on January 5, 2016 Governor Andrew M. Cuomo issued Executive Order No. 151 which, among other things, directs local social services districts to take all necessary steps to ensure that shelter and shelter services are available and provided to homeless individuals whenever inclement winter weather temperatures are at or below 32 degrees Fahrenheit, inclusive of National Weather Service calculations for windchill; and

WHEREAS, grant funds from the New York State Office of Temporary and Disability Assistance ("OTDA") in the amount of \$36,554 are available to our County Department of Social Services for the provision of shelter and shelter services to the homeless in order to facilitate local compliance with Executive Order No. 151; and

WHEREAS, in Saratoga County, Shelters of Saratoga, Inc. operates the Code Blue Shelter in Saratoga Springs, which prior to January 5, 2016 provided shelter to homeless individuals only when temperatures reached 20 degrees Fahrenheit between the hours of 7 p.m. and 7:30 a.m.; and

WHEREAS, our Commissioner of Social Services proposes utilizing said OTDA grant funds to: 1) enter into a contract with Shelters of Saratoga, Inc. to provide funding assistance in the amount of \$25,114 to cover certain additional costs associated with extending the Code Blue Shelter's hours of operation to comply with Executive Order No. 151 subsequent to January 5, 2016; and 2) apply the remaining \$11,440 in grant funds to cover any additional costs the Department of Social Services might incur for sheltering individuals or families that are not otherwise eligible for emergency housing and not able to be housed at the Code Blue Shelter; and

WHEREAS, our Social Programs Committee has recommended that this Board approve the Commissioner's plan for compliance with Executive Order No. 151; and

WHEREAS, the acceptance of these State OTDA grant funds requires our approval and an amendment to the 2016 County Budget; now, therefore, be it

RESOLVED, that the Chair of the Board and/or the Commissioner of Social Services are hereby authorized to execute any and all documents required to accept from the New York State Office of Temporary and Disability Assistance a grant in the amount of \$36,554 for the provision of those shelter and shelter services to the homeless needed to comply with Executive Order No. 151; and, be it further

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Shelters of Saratoga, Inc. for the reimbursement and payment of expenses associated with sheltering the homeless during the extended hours of operation of the Code Blue Shelter in Saratoga Springs required by Executive Order No. 151, for the term January 5, 2016 through July 1, 2016, and at a cost not to exceed \$25,114; and, be it further

RESOLVED, that the form and content of all said documents and agreement shall be subject to the approval of the County Attorney; and, be it further

AUTHORIZING AN AGREEMENT WITH THE TOWN OF CORINTH TO PROVIDE FUNDING IN AN AMOUNT NOT TO EXCEED \$20,000 FOR THE PURCHASE OF A TRANSPORTATION VEHICLE FOR SENIORS

WHEREAS, the County Office for the Aging administers State funds for the transportation of the County's elderly citizens; and

WHEREAS, the Town of Corinth is purchasing a vehicle for transportation of its senior citizens to local senior programs, and has requested that the County provide funding assistance in the form of a one-time grant in an amount not to exceed \$20,000 to be applied towards the costs of purchasing such vehicle; and

WHEREAS, the Director of the Office for the Aging recommends approval of this request; now, therefore, be it

RESOLVED, that the Chair of the Board of Supervisors execute an agreement with the Town of Corinth providing for the County's issuance of a grant to the Town in an amount not to exceed \$20,000 for the Town's purchase of a vehicle to be used in the transportation of local senior citizens to seniors' programs, with the form and content of such agreement being subject to the approval of the County Attorney.

AUTHORIZING A RENEWAL AGREEMENT WITH THE SENIOR CITIZENS CENTER OF SARATOGA SPRINGS TO PROVIDE \$20,000 IN FUNDING FOR THE CENTER'S COMMUNITY CONNECTIONS PROGRAM

WHEREAS, the Senior Citizens Center of Saratoga Springs operates a program known as the "Community Connections" program, which utilizes volunteers to provide non-medical services to the elderly in the Saratoga Springs area, which services include home visits, household chores, transportation, errands, and telephone check-ins; and

WHEREAS, pursuant to Resolution 76-2014, this Board authorized an agreement with the Senior Citizens Center to provide County funding in the amount of \$15,000 for the development and implementation of the Community Connections program, which funds were provided through a \$15,000 State grant; and

WHEREAS, pursuant to Resolution 58-2015, this Board authorized a one year renewal of the agreement with the Senior Citizens Center to provide County funding in the amount of \$20,000 for the Community Connections Program, which funds were provided through \$20,000 in State aid reimbursement, subject to a \$7,000 match by the Senior Center; and

WHEREAS, the Senior Citizens Center has requested to renew its funding agreement with the County for the Community Connections program for an additional term of one year commencing April 1, 2016; and

WHEREAS, our Social Programs Committee and the Director of our Office for the Aging have recommended that the funding request of the Senior Citizens Center for the sum of \$20,000 to continue the operation of the Center's Community Connections program be approved; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute a renewal agreement for the term April 1, 2016 through March 31, 2017 with the Senior Citizens Center of Saratoga Springs, Inc. for the provision of State and County funding to the Center in an amount not to exceed \$20,000, subject to a \$7,000 Senior Center match, for the continued operation of the Center's Community Connections program; with the form and content of such renewal agreement being subject to the approval of the County Attorney.

AUTHORIZING A RENEWAL AGREEMENT WITH HHDL, INC. D/B/A HOME HELPERS & DIRECT LINK TO PROVIDE ADDITIONAL COMMUNITY-BASED RESPITE AND PERSONAL CARE SERVICES FOR THE ELDERLY

WHEREAS, the Balancing Incentive Program (BIP) is a federal initiative authorizing grants to states to increase access to non-institutional community-based long-term services and supports; and

WHEREAS, Resolution 74 – 2015 authorized the acceptance of \$37,267 in BIP grant funding from the New York State Office for the Aging, to increase offerings and access to non-institutional long term services and supports for caregivers and their Medicaid-eligible care-recipients; and

WHEREAS, Resolution 74-2015 further authorized an agreement with HHDL, Inc. d/b/a Home Helpers & Direct Link of Saratoga Springs, New York, for the provision of caregiver support services to caregivers and their Medicaid eligible care-recipients at a cost of \$18.00 per hour for respite care/companionship services and at a cost of \$22.00 per hour for personal care services, for the term May 1, 2015 through March 31, 2016; and

WHEREAS, our Office for the Aging proposes to continue utilizing said BIP grant funding to renew the contract of HHDL, Inc. d/b/a Home Helpers & Direct Link for the provision of caregiver support services in the form of Level 1 respite care/companionship services at a cost of \$20.00 per hour and of Level 2 personal care services at a cost of \$22.00 per hour, for the term April 1, 2016 through June 30, 2017; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute a renewal agreement with HHDL, Inc. d/b/a Home Helpers and Direct Link of Saratoga Springs, New York, for the provision of non-institutional community-based caregiver support services to caregivers and their Medicaid-eligible care-recipients at a cost of \$20.00 per hour for Level 1 respite care/companionship services and at a cost of \$22.00 per hour for Level 2 personal care services, for the term commencing on April 1, 2016 and terminating on June 30, 2017, with the form and content of such agreement being subject to the approval of the County Attorney.

REQUESTING HOME RULE LEGISLATION TO AUTHORIZE THE COUNTY OF SARATOGA TO CONVEY A 63.54 ACRE PARCEL OF REFORESTED LANDS ON KINNS ROAD IN THE TOWN OF CLIFTON PARK TO THE TOWN OF CLIFTON PARK

WHEREAS, in 1938 the County acquired title to Tax Parcel #265.-2-9 on Kinns Road in the Town of Clifton Park through the County’s tax foreclosure process, by deed recorded in the Saratoga County Clerk’s Office in Book 401 of Deeds at Page 495; and

WHEREAS, pursuant to Resolution No. 76 of 1940, the Saratoga County Board of Supervisors approved the recommendation of its Reforestation Committee to dedicate and use the Kinns Road parcel for reforestation purposes; and

WHEREAS, from 1940 through the present date, the County has utilized and managed Tax Parcel #265.-2-9 consistent with the purposes authorized by County Law §219 and General Municipal Law §72-a; and

WHEREAS, pursuant to Resolution No. 264 of 1976, the Saratoga County Board of Supervisors authorized and directed the County’s Forestry Department, subject to the approval of the New York State Department of Environmental Conservation, to create a recreational area upon the Kinns Road parcel, with such work to include, but not be limited to, the thinning and pruning of trees, the removal of stumps, wood chipping, the erection and installation of rest rooms and picnic tables, and the building of fireplaces and hiking paths; and

WHEREAS, the County dissolved its Forestry Department around 1980, prior to the commencement of any work by the County to create the planned recreational area on the Kinns Road parcel; and

WHEREAS, over the ensuing decades, the Town of Clifton Park has constructed a series of multi-use trails throughout the 63.54 acre parcel, and has maintained the trail system, a picnic area and a parking lot at the Town’s expense; and

WHEREAS, the County’s parcel has come to be known as “Kinns Road Park”, and is heavily used by walkers, joggers, runners, hikers, cross-country skiers, dog walkers and others; and

WHEREAS, in accordance with the County’s Forestry Management Plan for the County’s reforested lands, the County planned to harvest selected trees and all dead and diseased trees on the Kinns Road parcel this year pursuant to best forestry management practices; and

WHEREAS, the County’s plans to selectively harvest the timber on the Kinns Road parcel met with significant opposition from the residents surrounding the Park, the users of the Park, Clifton Park residents and Town officials; and

WHEREAS, pursuant to Resolution No. 47 of 2016, the Clifton Park Town Board has stated the Town’s desire to acquire title to the Kinns Road Park parcel from the County in a manner consistent with state law and regulation; and

WHEREAS, on February 10, 2016 the County and the Town have entered into an intermunicipal agreement authorizing the Town to manage Kinns Road Park pursuant to the Forestry Stewardship Plan prepared by a certified forester retained by the Town, with said intermunicipal agreement to run for a term of the earlier of ten years or the date the County transfers title to the Kinns Road Park parcel to the Town pursuant to lawful authority; and

WHEREAS, while General Municipal Law §72-a authorizes the governing board of a town to acquire for such town tracks of land having forests or tree growth thereon, and to appropriate town monies therefor,

County Law §219 limits the potential transferees to which a county can convey title to county reforested lands to only the State of New York; and

WHEREAS, our Economic Development Committee has recommended that the County convey Tax Parcel #265.-2-9 to the Town of Clifton Park upon the conditions that: (1) the Town own and operate the Kinns Road Park parcel as reforested lands consistent with the statutory purposes and restrictions set forth in County Law §219; and (2) that the County obtains appropriate home rule legislation from the State Legislature and the Governor authorizing the County to make such conveyance to the Town; and

WHEREAS, in order to effect the proposed conveyance of the County’s reforested lands identified as Tax Parcel #265.-2-9 to the Town of Clifton Park, it is necessary that home rule legislation be enacted into law authorizing such conveyance; now, therefore, be it

RESOLVED, that the Board of Supervisors of the County of Saratoga hereby requests the enactment of state legislation authorizing the County of Saratoga to convey to the Town of Clifton Park reforested lands originally acquired by the County by deed dated June 20, 1938 and recorded in the Saratoga County Clerk’s Office in Book 401 of Deeds at Page 495, said lands being also identified as Tax Parcel #265.-2-9, subject to the condition that the Town of Clifton Park owns and operates said reforested lands in a manner consistent with and subject to the same statutory purposes and land use restrictions imposed on counties as set forth in County Law §219; and, be it further

RESOLVED, that the Clerk of the Board forward certified copies of this Resolution to our local legislators and the Town Supervisors and Town Clerk for the Town of Clifton Park.

WHEREAS, pursuant to Resolutions 230-2014 and 186-2015, the County entered into an agreement with GHD Consulting Services, Inc. to conduct an engineering study detailing available alternatives to the incineration of sludge at the Sewer District's Wastewater Treatment Plant; and

WHEREAS, in order to maintain proper plant function at the Wastewater Treatment Plant, the Sewer District desires to retain the services of a qualified company to remove, transport and dispose of 100% of the Sewer District's daily production of sludge to a properly permitted disposal facility while long term options identified in GHD's study are evaluated; and

WHEREAS, the Saratoga County Sewer District Commission solicited and entertained bids for a contract for the removal, transportation and disposal of sludge/biosolids by qualified haulers; and

WHEREAS, the Saratoga County Sewer District Commission and the Sewer District's Executive Director have reviewed the bids received and recommended that a contract for sludge hauling be awarded to GottaDo Contracting, LLC, the lowest bid received; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with GottaDo Contracting, LLC of Jordan, New York, for the removal, transportation and disposal of sludge/biosolids from Saratoga County Sewer District No. 1's Wastewater Treatment Plant for a term of one year commencing March 20, 2016, subject to renewal upon the mutual agreement of the parties for up to two additional terms of one year each, at a cost of \$74.66 per wet ton, with the form and content of such agreement to be subject to the approval of the County Attorney.
