AMENDING AN AGREEMENT WITH THE ALCOHOL AND SUBSTANCE ABUSE PREVENTION COUNCIL OF SARATOGA, INC. TO INCLUDE STATE-FUNDED COST-OF-LIVING INCREASES FOR THE CERTIFIED RECOVERY PEER ADVOCATE AND AMENDING THE 2024 COUNTY BUDGET IN RELATION THERETO

WHEREAS, Resolution 296 – 2021 authorized renewal agreements, subject to annual appropriations, with various agencies for mental health services between January 1, 2022 and December 31, 2024, including The Alcohol and Substance Abuse Prevention Council of Saratoga County, Inc. (“The Prevention Council”); and

WHEREAS, Resolutions 201 – 2022 and 202 – 2023 amended the aforementioned agreement with The Prevention Council to provide the County with additional Certified Recovery Peer Advocate (CRPA) Services at an additional cost not to exceed \$83,064, through an amended agreement whereby a Memorandum of Understanding outlining the additional CRPA services would be incorporated therein to the total agreement cost not to exceed \$825,848; and

WHEREAS, additional funds have become available from the New York State Office of Addiction Services and Supports (OASAS) in the amount of \$1,769, effective April 1, 2024, to provide a 2.84% Cost-of-Living Adjustment (COLA) for the CRPA working in the County’s Addiction Services Outpatient Clinic, for a total cost not to exceed \$84,833; and

WHEREAS, our Health and Human Services Committee has recommended the acceptance of the foregoing additional grant funds in the amount of \$1,769, which additional grant funds do not exceed 10% of the agreement amounts set forth in Resolution 296 – 2021 and amended thereafter by Resolutions 201 – 2022 and 202 – 2023, and that those funds be provided to the CRPA working in the County’s Addiction Services Outpatient Clinic at a total cost not to exceed \$84,833; and

WHEREAS, the acceptance of these additional funds requires an amendment to the 2024 County Budget; now, therefore, be it

WHEREAS, pursuant to Resolution 331 – 2022, this Board authorized an amendment to the Vacation Carryover Policy, allowing County employees to extend their approved vacation carryover accruals to their next accrual date; and

WHEREAS, Resolution 186 – 2024 approved the terms of a negotiated Memorandum of Agreement (MOA) with the Civil Service Employees Association (CSEA) authorizing a Collective Bargaining Agreement between the County and the CSEA for a term commencing January 1, 2024 and terminating December 31, 2028; and

WHEREAS, the terms of the MOA included a revision to the Vacation Carryover Policy, which stated that all or part of an employee’s unused vacation time may be carried over to the succeeding year, but must be taken within that next twelve (12) months or such carryover vacation days will be forfeited; and

WHEREAS, the Human Resources and Insurance Committee and the Director of Human Resources have recommended that the policy be amended to adopt these new vacation carryover terms authorized in the CSEA Collective Bargaining Agreement, that it be extended to County employees not represented by a Bargaining Unit, and that it be clarified for all members of each of the County’s Bargaining Units; and

WHEREAS, the Human Resources and Insurance Committee and the Director of Human Resources have recommended that the policy be amended to adopt the following terms:

Vacation Carryover Amendments:

Effective July 19, 2024, all or part of any County employee's unused vacation may be carried over to the succeeding year and must be taken within that next twelve (12) months or such carryover vacation days will be forfeited. Note: this policy applies to all full-time County employees who are not members of the CSEA Bargaining Unit or represented by another Bargaining Unit. Employees who are members of the Police Benevolent Association (PBA) and/or the United Public Service Employees Union (UPSEU) should refer to the negotiated language in the applicable section(s) of their respective Collective Bargaining Agreements for information pertaining to vacation carryover rules.

AWARDING 2024 TRAILS GRANTS

WHEREAS, the 2024 County Budget included a Trails Grant Program to give matching grants to local municipalities to fund trail development and construction projects; and

WHEREAS, the 2024 Trails Grant Program provides a pool of up to one hundred fifty thousand dollars (\$150,000) to fund trail feasibility studies, engineering work, and construction in local municipalities; and

WHEREAS, the Trails and Open Space Committee received fifteen (15) applications for funding totaling one hundred forty-eight thousand dollars (\$148,000), which the Committee recommended to be fully funded; and

WHEREAS, the Trails and Open Space Committee and the Law and Finance Committee approved fully funding all fifteen (15) applications submitted, at a cost of one hundred forty-eight thousand dollars (\$148,000) utilizing allotted 2024 Trails Grant funds; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors authorizes the payment under the 2024 Trails Grant Program of the sum of one hundred forty-eight thousand dollars (\$148,000) to the following municipalities for the purposes stated, upon condition that each municipality provide matching funds or services in-kind:

- 1. Town of Ballston:** The amount of ten thousand dollars (\$10,000) to be applied toward the Jenkins Park Trail Extension and Existing Trail Restoration to include the construction of 885 ft. of trail extension on the existing 2.5-mile trail network within the existing town-owned, 43-acre multi-use recreational park, and restoration of 2,450 l.f. of the existing trails with resurfacing and drainage repairs.
- 2. Town of Charlton:** The amount of ten thousand dollars (\$10,000) to be applied toward the LaRue Creek Covered Bridge Replacement to include replacement of a covered bridge that expands LaRue Creek and is part of the Saratoga County Snowmobile Trail Network. The bridge will be replaced with a 50 ft. x 8 ft. x 7 ft. covered bridge.
- 3. Town of Clifton Park:** The amount of ten thousand dollars (\$10,000) to be applied toward the Trail Boardwalk Restoration: Brookhaven to Park Lane Estates to include a repair/restoration of the existing 17-year-old pedestrian boardwalk section of the existing trail route that traverses wetlands on the south side of a steel bridge that expands the Dwaas Kill. This trail connects with other local trails that connect residential neighborhoods with public parks, school areas, and commercial ventures in town.

4. **Town of Corinth:** The amount of ten thousand dollars (\$10,000) to be applied toward the Trail Network/9N property to include funding for Phase I of the town's Master Plan of town-owned property to be utilized as a recreational park. Phase I will include the design, layout, and possibly material for 1.6 miles of planned trails in the park.
5. **Village of Corinth:** The amount of eight thousand dollars (\$8,000) to be applied toward the Upgrade Corinth Recreational Area Trails to include funds for a feasibility study and trail amenities, such as a new kiosk in the parking lot, benches along the trail, new trailhead markers, and new trail identification markers along the village's existing Upper Reservoir Trail Network.
6. **Town of Hadley:** The amount of ten thousand dollars (\$10,000) to be applied toward the Tennis Court/Basketball Course Refurbishing to refurbish existing tennis and basketball courts and replace some fencing surrounding the tennis courts in the town park.
7. **Town of Halfmoon:** The amount of ten thousand dollars (\$10,000) to be applied toward the Erie Canalway Trail Paving to pave a portion of the town's Mohawk Towpath Scenic Byway – or more specifically, 1,200 l.f. of existing stone dust trail from Whites Lane to the Crescent Boat Club.
8. **Town of Malta:** The amount of ten thousand dollars (\$10,000) to be applied toward the Malta Community Park Trail Restoration to refurbish a 0.62-mile nature trail of the 22.69-acre Malta Community Park with engineered wood fiber and replacing existing wayfinding signage with new signage.
9. **Town of Moreau:** The amount of ten thousand dollars (\$10,000) to be applied toward the Big Bend Trail Phase I Completion: Trail Amenities to include providing an accessible kayak launch into the Hudson River from the town's Phase I of the Big Bend Trail.
10. **Town of Northumberland:** The amount of ten thousand dollars (\$10,000) to be applied toward the Meadow in the Sky Trail – Hudson Point Crossing (Phase II) to include funding for the provision of over fifty (50) understory, native species of plants in between the oaks that will provide ecological benefits to the area. In 2023, Hudson Crossing Park completed Phase I of Meadow in the Sky Trail with a segment of "Allee of Oaks" of seven (7) different varieties of oak trees.
11. **Town of Saratoga:** The amount of ten thousand dollars (\$10,000) to be applied toward the townwide Restoration and Maintenance Project to include resurfacing of several trails, including trails connected to the Siege Trail, the Champlain Canal Trail, the town's Boat Launch Trail, and one more that connects to the Town of Stillwater with stone dust and fine rubble with emphasis on maintenance where trails are worn or washed out.
12. **City of Saratoga Springs:** The amount of ten thousand dollars (\$10,000) to be applied toward the Bog Meadow Brook Nature Trail Improvements to include the following: fix parking lot pot holes on both Route 29 and Meadowbrook Road parking lots, repair drainage issues in the Route 29 parking lot as well as Gilbert Road, perform maintenance on culverts and/or add new culverts between the Route 29 parking lot and the bridge over the Bog Meadow Brook, and replace or refurbish aging trail identification signs throughout the trail. The original improvements for the existing Trail Network date back to 1993, making them over thirty (30) years old.
13. **Village of South Glens Falls:** The amount of ten thousand dollars (\$10,000) to be applied toward the Betar Byway Public Restroom (Upper Trailhead) to include placing an Americans with Disabilities Act (ADA)-compliant portable toilet facility that connects to municipal water and sewer. The proposed restroom facility will be placed on the village's DPW lands in the upper section of the existing trail.

14. Village of Stillwater: The amount of ten thousand dollars (\$10,000) to be applied toward the Village of Stillwater Pedestrian Park to include construction of a Village Overlook Park on property neighboring the Stillwater Blockhouse. The project will include the creation of walkways, an expanded parking area, and a Hudson River Overlook constructed of Alaskan Cement Slab with stainless steel posts and cables.

15. Town of Wilton: The amount of ten thousand dollars (\$10,000) to be applied toward the Northern Pines Road Fishing Access Parking and Trail to include providing a parking lot and trail access to the Snook Kill off Northern Pines Road to provide fishing access to the Veterans Housing Community as well as to the general public. Funds will be used to provide grading of raw land and purchase of parking and trail construction materials.

ADOPTING A LOCAL LAW TO PROVIDE SALARY INCREASES FOR CERTAIN COUNTY OFFICIALS AND AMENDING THE 2024 COMPENSATION SCHEDULE

WHEREAS, Resolution 189 – 2024 introduced and presented a proposed Local Law identified as Introductory No. 2, Print No. 1 of 2024, to this Board of Supervisors and scheduled a public hearing thereon for August 14, 2024, at 4:35 p.m. in the Meeting Room of the Saratoga County Board of Supervisors, 40 McMaster Street, Ballston Spa, NY; and

APPROVING THE PROPOSED INCREASE IN THE MAXIMUM ESTIMATED COST OF PROPOSED UPGRADES TO THE SARATOGA COUNTY SEWER DISTRICT NO. 1 WASTEWATER TREATMENT PLANT TO PROPERLY TREAT AMMONIA AND MEET NEW LIMITS PROPOSED BY THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION

WHEREAS, by proceedings heretofore duly had and taken pursuant to Article 5-A of the County Law, the Board of Supervisors of Saratoga County, New York (the “Board of Supervisors”), established a county sewer district designated and known as Saratoga County Sewer District No. 1, in said County (the “District”); and

WHEREAS, the District operates pursuant to the terms and conditions of a State Pollution Discharge Elimination System (SPDES) Permit issued and regulated by the Department of Environmental Conservation (DEC); and

WHEREAS, the District’s SPDES Permit contains limits on the discharge of various pollutants and requirements for the measurement of said pollutants and the reporting of said measurements; and

WHEREAS, the District resolved violations of its SPDES permit by entering into administrative consent order with the DEC approved by Board Resolution 226-2019, and with the United States Environmental Protection Agency (USEPA) by Board Resolution 39-2020 and both consent orders called for the District to upgrade its existing facilities and properly treat ammonia (the “Project”); and

WHEREAS, following a public hearing held on July 13, 2022, the Board of Supervisors determined, pursuant to Resolution 251 - 2022 adopted July 19, 2022, that it is in the public interest of the people of the County of Saratoga residing within the boundaries of the District to undertake the Project at a maximum estimated cost of \$44,469,202, with the annual net cost to the typical property in the District as a result of the Project previously estimated to be \$8.00; and

WHEREAS, following a public hearing held on June 12, 2024, the Board of Supervisors subsequently determined, pursuant to Resolution 163-2024 adopted June 18, 2024, that it is in the public interest of the people of the County of Saratoga residing within the boundaries of the District

to undertake the Project at an increased maximum estimated cost of \$48,228,452, at a revised annual net cost to the typical property in the District of \$11.63; and

WHEREAS, the estimated maximum cost of the Project has increased from \$48,228,452 to \$52,628,452; and

WHEREAS, the estimated maximum annual net cost to the typical property in the District is estimated to be \$11.63; and

WHEREAS, on July 16, 2024 the Board of Supervisors duly adopted Resolution 181-2024, calling a meeting of the Board of Supervisors for the purpose of holding a public hearing regarding the proposal to construct the Project at the increased maximum estimated cost described above; and

WHEREAS, such Resolution authorized and directed the Clerk of said Board of Supervisors to publish the notice of public hearing; and

WHEREAS, said public hearing was duly held in the Meeting Room of the Saratoga County Board of Supervisors, 40 McMaster Street, in the Village of Ballston Spa, New York, in said County, on August 14, 2024 at 4:30 p.m.; and

WHEREAS, notice of said public hearing was duly published and filed in the manner provided by law and proof thereof was submitted to said Board of Supervisors;

NOW, THEREFORE BE IT

RESOLVED, that it is hereby found and determined that it is in the public interests of the people of the County of Saratoga residing within the boundaries of the District to proceed with the Project, all as more fully described in the preambles hereof, and such increase and improvement of District facilities is hereby authorized at the increased maximum estimated cost of \$52,628,452; and be it further

RESOLVED, the expense of said increase and improvement of District facilities shall be financed by (a) the issuance of bonds in an amount not to exceed \$48,228,452 of said County, and (b) the expenditure of federal and New York State grant funds for costs not financed with County bonds, and the costs of said increase and improvement of District facilities, including payment of principal of and interest on said bonds, shall be apportioned in accordance with the District's annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and will be amended and adopted on an annual basis, with the expectation that any funds received by the District from federal or New York State grants shall be used to pay a part of the cost of the project or to pay debt service on bonds issued to finance the project or shall be budgeted as an offset to such assessments to be levied and collected; and be it further

RESOLVED, that this Resolution shall take effect immediately.

WHEREAS, the County Board of Supervisors of the County of Saratoga, New York on August 17, 2021 adopted a Bond Resolution (the “Original Bond Resolution”) entitled “RESOLUTION 240-2021 AUTHORIZING THE ISSUANCE OF \$33,100,000 BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF CONSTRUCTION OF UPGRADES TO AMMONIA TREATMENT FACILITIES BY SARATOGA COUNTY SEWER DISTRICT NO. 1; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$33,100,000, STATING THE PLAN OF FINANCING; PROVIDING FOR A TAX TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS; AND PROVIDING FOR REIMBURSEMENT BY SARATOGA COUNTY SEWER DISTRICT NO. 1 TO SAID COUNTY”; and

WHEREAS, on July 13, 2022, the County Board of Supervisors adopted a Supplemental Bond Resolution entitled “RESOLUTION 250 - 2022 BOND RESOLUTION AUTHORIZING THE ISSUANCE OF AN ADDITIONAL \$11,369,202 SERIAL BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF CONSTRUCTION OF UPGRADES TO AMMONIA TREATMENT FACILITIES BY SARATOGA COUNTY SEWER DISTRICT NO. 1.” (the “First Supplemental Bond Resolution”); and

WHEREAS, on June 18, 2024, the County Board of Supervisors adopted a Supplemental Bond Resolution entitled “RESOLUTION 162 - 2024 BOND RESOLUTION AUTHORIZING THE ISSUANCE OF AN ADDITIONAL \$3,759,250 SERIAL BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF CONSTRUCTION OF UPGRADES TO AMMONIA TREATMENT FACILITIES BY SARATOGA COUNTY SEWER DISTRICT NO. 1.” (the “Second Supplemental Bond Resolution”); the Original Bond Resolution, the First Supplemental Bond Resolution and the Second Supplemental Bond Resolution are collectively referred to as the “Prior Bond Resolutions”); and

WHEREAS, the County Board of Supervisors wishes to authorize the expenditure and appropriation of additional funds in connection with the construction of improvements and upgrades to the Saratoga County Sewer District No. 1 (the “District”) facilities in order to treat

ammonia, and the acquisition of land or rights in land and acquisition of original furnishings, equipment, machinery or apparatus required in connection therewith (the “Project”);

NOW, THEREFORE, BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Board of Supervisors of the County of Saratoga, New York as follows:

Section 1. The County of Saratoga, New York (herein called “County”), is hereby authorized to undertake the Project at an estimated maximum cost not to exceed \$52,628,452, constituting an increase of \$4,400,000 over the amount previously authorized in the Prior Bond Resolutions.

Section 2. The plan for financing such new maximum authorized cost of \$52,628,452 shall be as follows:

(a) by the issuance of \$48,228,452 of Serial Bonds of the County (the “Bonds”) previously authorized to be issued pursuant to the Prior Bond Resolutions; and

(b) by the expenditure of \$4,400,000 of federal or New York State grant funds to be received by the County for such objects or purposes, which is hereby authorized.

Section 3. It is hereby determined that the period of probable usefulness for the specific object or purpose is forty (40) years pursuant to paragraph 4 of Section 11.00(a) of the Local Finance Law; provided, however, that the maximum maturity of the Bonds shall be computed from the date of issuance of the first issue of bonds or bond anticipation notes authorized pursuant to the Prior Bond Resolutions.

Section 4. Pursuant to Section 107.00(d)(9) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

Section 5. The temporary use of available funds of the County, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

Section 6. As set forth in the Prior Bond Resolutions, the Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the County, payable as to both principal and interest by a general tax upon all the real property within the County without legal or constitutional limitation as to rate or amount. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be assessed and levied upon the real property of users connected to the District’s sewer system, in accordance with the District’s annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and as it will be amended and adopted on an annual basis, an amount sufficient to pay the principal of and interest on such obligations as the same become due and payable, but if not paid from such source, all the taxable real property in the County shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal

and interest on such obligations when due. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, and as set forth in the Prior Bond Resolutions, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for level or substantially level or declining annual debt service, is hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

Section 8. This resolution is intended to constitute the declaration of the County's "official intent" to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Regulation Section 1.150-2. Other than as specified in this resolution, no moneys are reasonably expected to be, received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the County Treasurer, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other bond resolutions previously or heretofore adopted by the Board of Supervisors of the County for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolutions. All matters regarding the sale of the bonds, including the dated date of the bonds, the use of electronic bidding, the consolidation of the serial bonds and the bond anticipation notes with other issues of the County and the serial maturities of the bonds are hereby delegated to the County Treasurer, the Chief Fiscal Officer of the County.

Section 10. The validity of the Bonds authorized by the Prior Bond Resolutions and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

(a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money; or

(b) the provisions of law which should be complied with at the date of the publication of this resolution or a summary hereof are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

(c) such obligations are authorized in violation of the provisions of the Constitution.

Section 11. The County Treasurer, as Chief Fiscal Officer of the County, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the

County to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12, as amended.

Section 12. This resolution, or a summary of this resolution, shall be published in the official newspapers of the County for such purpose, together with a notice of the Clerk of the County in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 13. This resolution is not subject to a mandatory or permissive referendum.

Section 14. The Board of Supervisors of the County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution.

Section 15. This resolution shall take effect immediately upon its adoption.

WHEREAS, the engineering and construction of Aeration Tank No. 7 was subject to investigation and litigation between the Sewer District and the Engineer of Record due to suspected deficiencies in design and construction; and

WHEREAS, the engineering report prepared by O'Brien & Gere recommended that the slab floors of Aeration Tank Nos. 5-8 be replaced due to defective design and construction, and that the new slab floors be secured by a rock-anchor system; and

WHEREAS, a Memorandum of Understanding (hereinafter the “MOU”) is needed to outline the basic terms and conditions under which the County and the Non-Profit will collaborate to build and operate the aforementioned Code Blue Shelter; and

WHEREAS, the MOU shall outline the County’s general responsibilities in respect to the aforementioned collaboration, including acquiring a suitable parcel of land in Saratoga Springs, New York, leasing the acquired parcel of land to the Non-Profit, establishing the best practices and service standards for the operation of the Code Blue Shelter, and exercising final authority over which programs are conducted on the property; and

WHEREAS, the MOU shall also outline the Non-Profit’s general responsibilities, including designing and constructing the Code Blue Shelter on the leased land, submitting the detailed design and construction plans for the Code Blue Shelter to the County for approval, outlining the day-to-day operations of the Code Blue Shelter, including staffing, management, and provision of services to shelter residents, ensuring that the shelter operates in accordance with the best practices and service standards established by the County, and only conducting programs on the premises that have been approved in writing by the County; and

WHEREAS, the MOU shall also outline the basic financial arrangements, including acknowledgment that the County will bear the full cost of purchasing the land, the Non-Profit will be responsible for all costs associated with the construction of the Code Blue Shelter, the Non-Profit owning, repairing and maintaining any building it constructs on the land, ownership of all such buildings will transfer from the Non-Profit to the County free and clear of any encumbrance at the end of the lease at no additional cost to the County; the County shall retain ownership of any buildings existing on the property at the time of the purchase of the land; the County shall own the land; and the Non-Profit will be responsible for covering all operational expenses, including but not limited to staffing, utilities, and maintenance; and

WHEREAS, any additional financial arrangements will be addressed in the lease agreement; and

WHEREAS, the MOU will go into effect pursuant to when the County executes a binding contract for the acquisition of the parcel of land; and

WHEREAS, the MOU will remain in effect until the County and the Non-Profit enter into a binding land lease agreement, unless terminated earlier by a mutual agreement; and

WHEREAS, the Law and Finance Committee and the Commissioner of the Department of Social Services recommend that the County enter into the aforementioned MOU; now, therefore, be it
