# DESIGNATING THE SARATOGA CONVENTION & TOURISM BUREAU, ALSO KNOWN AS DISCOVER SARATOGA, AS THE COUNTY'S TOURISM PROMOTION AGENCY AND AUTHORIZING THE SARATOGA CONVENTION & TOURISM BUREAU TO APPLY FOR AN "I LOVE NEW YORK" GRANT FOR 2025

**WHEREAS**, Article 5-A of the Economic Development Law authorizes matching funds for tourism promotion to be administered through a County's Tourism Promotion Agency; and

**WHEREAS**, approval of any application for such State funds requires the designation of a Tourism Promotion Agency and a local commitment for an amount at least equal to the grant request; and

**WHEREAS**, the maximum possible grant for tourism promotion for 2025 approximates \$172,500; and

**WHEREAS**, tourism promotion has long been a commitment of the Board of Supervisors of Saratoga County; now therefore be it

**RESOLVED**, that the Saratoga Convention & Tourism Bureau is hereby designated as Tourism Promotion Agency, effective January 1, 2025, for Saratoga County for the 2025 program year; and, it is further

**RESOLVED**, that the Chair of the Board is authorized and directed to execute and file necessary applications, acceptance and subrecipient documents required by the New York State Empire State Development for the maximum award of tourism promotion matching funds for 2025 with a possible total program expenditure of \$172,500; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

# Saratoga County Economic Development Grants Updates

## Reimbursement Requests and Reserve Fund Transfer

The Towns of Edinburg and Greenfield are seeking reimbursement for their Economic Development Grant projects. Committee approval is required for the municipalities to be reimbursed. Secondly, a board resolution is required for the transfer of funds from the Economic Development Grant Reserve Account (A.0888.ED) to the Municipal Planning Grant Program (A.80.000-8763). The total amount of the transfer is \$753.63 for the 2023 Greenfield Grant. 2024 grants do not need a transfer.

## Grant updates

#### Saratoga County Planning and Zoning Conference Update

The Planning and Economic Development Department has been working diligently for the Saratoga County Planning and Zoning Conference that will occur on February 5<sup>th</sup>, 2025. The course materials are being finalized, and solicitation of quotes for services for the conference are underway. Approvals will be requested at the December Economic Development meeting relating to the conference.

#### **Economic Development Around the County**

Staff attended the highly anticipated ribbon cutting for Soleno, LLC in Saratoga Springs on September 26, 2024. The event hosted by the Saratoga County Chamber of Commerce describes the new business "Soleno is a Canadian manufacturing company that produces high-density polyethylene pipes for storm water management, proud to celebrate the opening of its first plant outside of Canada in Saratoga, New York. This investment marks a significant milestone in our company's expansion, following successful ventures in Ontario and New Brunswick. The Saratoga plant will serve as the launchpad for the latest product line, KUSTOMFLO, which utilizes the advanced German Krah Pipes technology acquired in 2022. With this facility, we are poised to better serve our customers across the East Coast of the United States and in Canada, and to continue driving innovation in water management solutions." About 150 attendees were treated to a tour of the facility.

Staff attended the Saratoga County Chamber of Commerce Business Showcase on October 3, 2024 at the Gideon Putnam Hotel in Saratoga Springs. The approximately 80 exhibitors were businesses and non-profit organizations from Saratoga County and beyond showcasing what they offered locally to about 500-600 attendees.

Staff attended the Mechanicville-Stillwater Economic Summit on October 10, 2024 at the Arts Center on the Hudson in Mechanicville. The Mechanicville-Stillwater Chamber of Commerce hosted the event with about 165 people in attendance. This year's honorees were Adirondack Basement Systems and Chase-Smith Funeral Home. Mayor Butler of the City of Mechanicville received the 1<sup>st</sup> "Jack Byrne" Community Service Award.

#### **Grant Opportunities**

The **Capital Region Transportation Council** is seeking applications for community planning, technical assistance, municipal complete streets workshops, and other transportation planning initiatives for inclusion in the work plan that begins on April 1, 2025. Municipalities within Saratoga County, except the Town of Moreau and the Village of South Glens Falls, are eligible to apply.







#### Calling All OCTOGENERIANS

Do you know any TOG residents who will be celebrating their 100<sup>th</sup> birthday? Don't forget to let us know so we can honor them properly! If you've noticed a lot of construction along the railroads in the Clinton, Denton and Daniels Road area, we have some answers for you.

Champlain Hudson Power Express is building a 339mile power transmission line from Hvdro-Ouebec in Canada to New York City for clean energy transmission. This renewable hydropower energy will be built underground through the waterways, along railroads, roads and both public and private land. In Greenfield, the route crosses only in the area mentioned above in the "right of way" along the train tracks. The work in Greenfield began around June of 2024 and is expected to continue through January of 2025. Work includes clearing of trees, constructing the utility trench to place the cables in, and a process known as Horizontal Directional Drilling (HDD) that allows the cable to go deeper underground to avoid obstacles.

CHPE has asked for permission from each and every town and private land owner involved. In Greenfield, CHPE entered agreements with landowners to use two private parcels, securing permanent and temporary easements by mutual agreement in March of 2023. If you have not been contacted by CHPE, the

project will not impact your private property.

Greenfield's Town Board approved to support this project by resolution on Sept. 10, 2020. The town entered a road use agreement that was signed Feb. 8, 2024, detailing the parameters for the work that crosses the affected Denton Road.

The energy will be delivered to a converter station in Astoria Queens, N.Y. and will benefit Con Edison customers. According to CHPE's Director of Stakeholder Engagement Andrew Rush, there will be significant economic and environmental benefit for every community along the project's path.

In addition to hiring local contractors, like MJ Engineering in Clifton Park, CHPE has arranged a substantial payment revenue to the town, Saratoga County and the Saratoga Springs School District during the 40 to 60-year operating life of the project. More than \$126 million dollars will be paid to Saratoga County, and the county will distribute approximately \$5 million in funds to each of the impacted communities, including Greenfield.

CHPE also has a community engagement fund to support local initiatives. In Greenfield, officials are still working out what this project will include. The plans should be solidified by September. One thing being considered, according to Supervisor Kevin Veitch, is a project to run electric in Brookhaven Park, which will allow us to finish plans for development of a bathroom and renovated pavilion at that site. Stay tuned to hear more.

"We recognize that our work does cause some amount of inconvenience to those living near the sites, such as tree removal and traffic delays," Rush said. "We look to minimize the impacts to the resident the best we can." (cont'd next page, right column)

# Food Pantry Seeking Donations

More residents than ever before are using the weekly Greenfield Food Pantry, sponsored by St. Joseph's Church. Resident Heidi Lampert and her team of helpers began running the pantry after long-time volunteer Patty Schwartzbeck handed over its reigns. Lampert coordinates the food purchase, most of which comes from the Regional Food Bank in Latham, N.Y.; the food donations; and the staffing for each Wednesday's 1:30-3:30 p.m. event at the Community Center.

Volunteer Mike Ruhm and the pantry's financial coordinator Debi Ficaretta have been actively seeking grants to help with the purchase of food. In recent months the pantry has received \$2,500 from Stewart's Shops' "Holiday Match" program and \$5,000 from the Hawley Foundation for Children. The Saratoga County **Board of Supervisors** recently donated \$2,000 to the Regional Food Bank to use at its Greenfield Food Pantry. More donations have come from the Baptist Church, Greenfield Volunteer Fire Co. #1, Charles R. Wood Foundation, Ballston Spa National Bank, Ancient Order of Hiberians, and numerous private family donors.

To use the food pantry, residents are asked to supply proof of address in the Town of Greenfield and the number of household residents.

Veitch said this project will allow us to fund upgrades to our public infrastructure with little impact to our tax base. One such project in consideration is a new community center adjacent to Greenfield Town Hall.

# New Law to Protect Property Owners from Squatters

Have you heard of squatters? Squatters are individuals or groups who take up residence on a property without the owner's permission. Especially if you do not reside at your property or do not carefully monitor structures on your property, this can become a legal issue.

Many states and communities have enacted laws to protect residents from squatters having legal rights to your property. Greenfield residents are protected under an "Unlawful Intruder Law" that was passed in the May 21, 2024 meeting of the Saratoga County Board of Supervisors.

"The Saratoga County Board of Supervisors have taken a proactive approach to protect property owners from being unlawfully invaded and occupied," said Saratoga County Board of Supervisors Chairman Phil Barrett (Clifton Park) in a recent news release. "The new legislation is clear, concise, easily enforceable, does not pre-empt New York State Law and is supported by

court decisions. Someone who unlawfully enters a home in the first instance will never acquire tenant rights."

Barrett also stated the issue of squatters assuming control of private property is growing in New York and other areas of the country. A copy of the law is available at the County's website, www.saratogacountyny.go v/departments/board-ofsupervisors/local-law/.





# 10/23/2024 Update on Saratoga County Agriculture Conversations, Challenges and Opportunities

The following observations were compiled from meetings and conversations with Saratoga County farmers, Cornell Cooperative Extension, and others across the region.

# Farmland Preservation vs. Farm Business Preservation

"The best farmland preservation program is financially healthy farms" Northumberland Supervisor Bill Peck

"We no longer protect the farming way of life...." Nicolina Foti, Agriculture Dep't., CCE

From sitting in meetings especially in southern Saratoga County it appears the emphasis is being placed on preserving the scenic view, the "open space" nature of farms without regard for the viability of the farm business located on the land.

Observation: Abandoned farms are open space. Working farms are agricultural manufacturing operations and should be seen as such.

### Farms as 401(k)s

In 2015, the Halfmoon Business and Economic Development Committee conceived "Area 5" as a possible Agricultural-Residential district, changing from light industrial zoning to preserve what was perceived as the actual use of the land in the northwest corner of the Town.

In 2024, the Halfmoon Comprehensive Planning Update Committee received feedback from landowners in the proposed "Area 5" part of town that they opposed any change in zoning, because it would reduce the value of their land and eliminate options for them to cash in on their real estate investment.

Example: Betts Farm, Halfmoon - has been in continuous operation since 1860, but now occupies only a small portion of its former land. The rest has been turned into a large-scale housing development. Many area farms are being sold in whole or in part to provide retirement income for aging farmers or to otherwise cash in on their investment.

Per Cornell CCE, historically farms were on large parcels, but over the generations pieces were sold off to provide income or housing for children/siblings. This is now at a critical stage because so many area farms have shrunk considerably since the founding of Saratoga County.

## Younger Generation - Teaching Them to Lead and Making the Handoff

The age of farm owners in some areas is closing in on 80. They remain active on the farms, and in the community, but as we learned with the discontinuation of the Agriculture Promo Group and the combination of the CCE, Saratoga County Farm Bureau and the Saratoga County Ag Society Annual Meetings into one event, finding volunteers and people to participate is becoming more and more difficult.

Younger generations of farmers are not as community connected as their grandparents and parents were (and often still are).

The Chamber of Commerce needs more participation from younger members of the agriculture community, so that the rest of the business community is aware of and sensitive to the needs and changing landscape of the farming industry.

# TDR/PDR Into Oblivion (an alternative viewpoint)

Transfer/Purchase of Development rights was designed to help a farmer handle the cost of running the farm, and reduce development pressures on their operations by eliminating the possibility of turning the farm into something other than a farm (i.e. a more valuable (per acre) use of the farmland). However, some are pointing out that the money from the program is often invested by the current property owner in the farm, and once that farm owner passes, their heirs may end up with in a Catch-22: an unprofitable, unviable farm business located on land they cannot sell to anyone other than another farmer. Its possible that future generations may actually be forced OUT of farming by this issue, because they might have been able to sell their Clifton Park land to a developer and purchase land in Galway instead, but without the ability to divest of the untenable farmland they would not have this opportunity.

Different opinions exist on this subject. Willow-Marsh Farm has made good use of the TDR/PDR program. There are also temporary and permanent versions of the program. Like anything else, TDR/PDR is a tool. However, as the saying goes, "when the only tool in your box is a hammer, everything becomes a nail".

The question is whether other tools can be included in the toolbox to support the viability of farm businesses rather than concentrating solely on the land.

Observation: No other business genre associated with the Chamber of Commerce puts so much concentration into reducing the cost (and value!) of the premises on which it does business as a primary goal.

In Clifton Park, a property that is not covered under a TDR/PDR arrangement is now the subject of an Article 78 lawsuit because of a community disagreement over whether a proposed development violates the spirit and letter of the town's Conservation Residential zoning. The issue was exacerbated because a nearby farmer, who is under a TDR/PDR agreement, led an organized opposition during planning board hearings and in media, arguing that the development of 23 homes so close to the farm would impede operations and cause adjacent homeowners to complain about the normal activity that takes place on a farm. Similar issues have happened at farms in the Town of Ballston over the years, and elsewhere.

Some may argue that a valuable educational opportunity is being lost in this process, as the developer, realtor and prospective homeowners could be taught what actually happens on a farm before they move into the area. In the opinion of some, a symbiotic relationship could be developed between farm owner and nearby homeowners.

In the end, the Town may lose the lawsuit, and then the homes will still be built, except now there is bad blood between neighbors, and this seems unfortunate.

### The Rise of the "Gentleman Farm" - Family Agriculture's Future?

In 2022 the Town of Milton reduced the size of an unrestricted farm parcel to 2 acres. During the town meeting where this measure was adopted there was a lot of talk about "trusting" the residents of Milton to responsibly make their own property management decisions. Other towns are considering similar measures. Farms where the primary income is not derived from the farm itself will help alleviate the issue of land values, since families that draw on other income sources will be able to afford more expensive properties. Also, this encouragement of farming activities, even on a small scale, across the community helps build awareness of the opportunties, challenges, responsibilities and pitfalls of owning a farm, a priceless education campaign that should be augmented by CCE, the 4-H, Agricultural Society, Chambers of Commerce, and other organizations associated with the farm industry in Saratoga County

### Aggregation of Farm Products for Distribution

CCE has some statistics on where farm products are delivered in New York State. Its very difficult to meet demand with a varied growing season found here in upstate New York, and at the same time the lack of reliability consistent demand from restaurants or other consumers makes it hard for area farmers to plan for full capacity. Saratoga County farms could produce more if they had a more consistent, measurable and lucrative demand for their products. According to CCE, some work is being done statewide on this problem. It would seem worthwhile for Saratoga County to consider all options to support an aggregation facility within its borders if one becomes feasible.

#### Identifying Other Opportunities

It's possible that opportunities to sell more farm products to local or regional consumers are being overlooked.

CCE is working on the TasteNY operation at the Exit 18 Rest Area, which is tightly regulated by Federal rules dating back to the mid-1950s. Similarly, the Capital Region Chamber/Chamber of Southern Saratoga County operates the info center at Exit 9 that can coordinate with the CCE operation farther north and help promote it. Or even work with CCE to offer more farm products at Exit 9 if something can be done to change the Federal regulation at both centers.

Are other area stores a possibility for distributing more local farm products?

- Small local grocers
- Stewart's Shops
- Farmer's Markets
- Festivals
- Online

Can farmers continue to diversify their offerings and thus increase their profits and viability? Is Agri-Tourism an option?
